

PRIVACY POLICY FOR i-DEALCORP.COM

This privacy policy provides information on how i-deal Corp Limited ("iDeal") uses personal data relating to users ("you") of its website (the "Website").

1. Who is iDeal?

i-deal Corp Limited is a company registered in England and Wales with company number: 10138210. The company's registered office is in 2nd Floor, Berkeley Square House, Berkeley Square, London, W1J 6BD, United Kingdom.

iDeal is merely a platform to enable communications to be made.

iDeal **DOES NOT**: arrange or bring about deals; **DOES NOT** make introductions, assist, facilitate or promote deals to Company or Investor

You can contact iDeal by using the contact details set out at paragraph 9 below.

2. Collection and use of data by iDeal

2.1 Registration details

If you choose to register on the Website, you will be asked to provide to iDeal certain information about yourself, or the person on whose behalf you are authorised in order to create an account. Registration information may include:

- a contact telephone number and email address;
- a physical address; and
- other relevant information, such as your preferences regarding investment opportunities or news.

You will also be asked to set a password to give access to your account.

2.2 Contacting iDeal

If you contact iDeal in relation to the Website (via email, telephone, post or otherwise), we may collect and retain your contact details and your communication for the purpose of handling your query and keeping records of communications.

3. iDeal's use of your personal data

iDeal may also use and disclose your personal data for the purposes of:

- checking your compliance with the applicable terms and conditions for use of the Website;
- administration and maintenance of the Website and the services available on it;
- compliance with legal obligations, or protection and enforcement of legal rights;

- analysis and statistics (see paragraph 4 below);
- subject to obtaining your consent, sending you marketing communications by email; and
- managing actual or potential business transactions (eg in the case of an acquisition of iDeal's business).

4. Analysis and statistics

iDeal may use the data it collects about you for analysis and statistical purposes, for example to analyse how many Investors contacted a Company regarding a particular investment opportunity.

5. Disclosure of your personal data to third parties

iDeal may disclose your personal data for the purposes outlined at paragraphs 2 to 4 above to third parties, including:

- our service providers and professional advisers;
- governmental bodies and law enforcement authorities;
- other third parties where required or permitted by law.

iDeal will never sell information that can be used to personally identify you to a third party.

6. Storage and security of your personal data

Your personal data is stored in electronic and or physical records maintained by iDeal and/or its service providers. Whilst iDeal operates in the UK, it and its service providers may have servers located overseas, where the laws may not give the same level of protection to personal data as within the UK. By submitting your personal data, you agree to allowing your personal data to be transferred, processed and stored overseas as set out in this paragraph.

7. Removal of your details

You may request deletion of your account on the Website in accordance with the relevant clause in the applicable terms and conditions.

However, iDeal may retain certain aspects of your account and other personal details for the purposes of maintaining records of their dealings with you, analysis and statistics.

iDeal may delete your account in accordance with the relevant clauses in the applicable terms and conditions, including in the circumstances where you breach its terms or have not used the Website for a substantial period of time.

8. Access to your details

If you would like to access a copy of any personal data which iDeal hold about you, or if you wish to change your consent regarding marketing communications, please send a request by email or by post using the contact details in paragraph 9 below. An administration fee of £100 plus VAT may be charged to access your details.

You have the right, in certain circumstances, to object to iDeal processing your personal data or to request that your personal data is corrected or deleted. Please contact us using the contact details in paragraph 9 below.
